**An Ordinance to Extend the Corporate Limits
of the Town of Holly Springs, North Carolina**

WHEREAS, the Town Council of the Town of Holly Springs has been petitioned pursuant to the provisions of N.C.G.S. 160A-31 to annex the area described herein; and

WHEREAS, the Town Council of the Town of Holly Springs has directed the Town Clerk to investigate the sufficiency of the petition for annexation; and

WHEREAS, following the certification of the sufficiency of the petition by the Town Clerk, the Town Council fixed a date for a public hearing on the question of annexation and caused a notice thereof to be published in a paper of general circulation in the Town of Holly Springs once ten days prior to the date of the hearing; and

WHEREAS, the Town Council found as a fact following public hearing on the matter that the petition for annexation is sufficient and meets all of the requirements set forth in N.C.G.S. 160A-31;

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF HOLLY SPRINGS,
NORTH CAROLINA:**

Section 1. By virtue of the authority granted by N.C.G.S. 160A-31, the following described territory is hereby annexed and made part of the Town of Holly Springs effective as of the 15th day of May, 2018.

Legal Description for Voluntary Annexation

Michele Lacatena

Commencing from The Town of Holly Springs Monument "Van Fossen" having N.C. Grid Coordinate (NAD 83) values of North – 694,872.990, East – 2,061,891.100;

THENCE North 39 degrees 03 minutes 46 seconds West for a distance of 9,517.32 feet (grid distance) to an existing iron pipe having N.C. Grid Coordinate values of North - 702,262.756, East – 2,055,893.665, being the southeastern most point of Lot F as shown in Book of Maps 1987, Page 880 in

the Wake County Register of Deeds, and being the point and place of BEGINNING;

THENCE from said point of beginning North 88 degrees 29 minutes 09 seconds West for a distance of 229.71 feet to an existing iron pipe;

THENCE North 02 degrees 24 minutes 48 seconds East for a distance of 173.71 feet to a point on the southern right-of-way of Sunset Lake Road;

THENCE North 02 degrees 24 minutes 48 seconds East for a distance of 30.00 feet to a point in the centerline of Sunset Lake Road;

THENCE with the centerline of Sunset Lake Road the following courses and distances: North 88 degrees 57 minutes 39 seconds East for a distance of 136.35 feet to a point;

THENCE South 87 degrees 45 minutes 31 seconds East for a distance of 93.58 feet to a point;

THENCE leaving said centerline South 02 degrees 24 minutes 48 seconds West for a distance of 30.00 feet to a point on the southern right-of-way of Sunset Lake Road;

THENCE South 02 degrees 24 minutes 48 seconds West for a distance of 178.60 feet to the point and place of beginning. Together with and subject to covenants, easements, restrictions of record. Said property contains 1.095 acres more or less.

Section 2. Upon and after the effective date of annexation, the above described territory and its citizens and property, shall be subject to all debts, laws, ordinances and regulations in force within the Town of Holly Springs and shall be entitled to the same privileges and benefits as other parts of the Town of Holly Springs. The territory shall be subject to municipal taxes according to N.C.G.S. 160A-31.10.

Section 3. The Town Clerk of the Town of Holly Springs shall cause to be recorded in the office of the Register of Deeds of Wake County, and in the office of the Secretary of State, an accurate map of the annexed territory, described in Section 1, hereof, together with a duly certified copy of this ordinance.
