A Proclamation By The Mayor

In Recognition of National Farmers Market Week

WHEREAS, farmers markets are important outlets for agricultural producers nationwide, providing them with increased opportunities to meet consumer demand for a variety of fresh, affordable, convenient, and healthful products sold directly from the farm; and

WHEREAS, farmers markets play a key role in developing local and regional food systems that support the sustainability of family farms and preserve farmland and open space adding to our quality of life; and

WHEREAS, farmers markets allow consumers access to locally produced, farm-fresh food and the opportunity to personally interact with producers to learn about their products and to know exactly where their food comes from and how it was grown or produced; and

WHEREAS, purchasing products at a farmers market is environmentally sound as the average distance food travels from farm to plate in the United States is increasing and buying locally drastically reduces “food miles” saving fossil fuels; most products at farmers markets do not have packaging; and most local farmers use sustainable, humane or organic methods; and

WHEREAS, Holly Springs Farmers Market provides opportunities for citizens to gather, build community, contribute to the economic and social vitality of Holly Springs, create a positive social experience; and

WHEREAS, the U.S. Department of Agriculture recognizes the myriad of benefits of farmers markets for producers and consumers and is fully committed to supporting farmers markets’ continued success and to further awareness of farmers markets’ contribution to American life, Sonny Perdue, Secretary of the U.S. Department of Agriculture has proclaimed the week of Aug. 5 - 11, 2018 as National Farmers Market Week;

NOW, THEREFORE, to further encourage residents of Holly Springs to enjoy Holly Springs Farmers Market managed by the Town of Holly Springs Department of Planning & Zoning since 2007, I, Mayor Dick Sears, do hereby proclaim the week of Aug. 5 - 11, 2018 as
