**An Ordinance to Extend the Corporate Limits  
of the Town of Holly Springs, North Carolina**

**WHEREAS**, the Town Council of the Town of Holly Springs has been petitioned pursuant to the provisions of N.C.G.S. 160A-31 to annex the area described herein; and

**WHEREAS**, the Town Council of the Town of Holly Springs has directed the Town Clerk to investigate the sufficiency of the petition for annexation; and

**WHEREAS**, following the certification of the sufficiency of the petition by the Town Clerk, the Town Council fixed a date for a public hearing on the question of annexation and caused a notice thereof to be published in a paper of general circulation in the Town of Holly Springs once ten days prior to the date of the hearing; and

**WHEREAS**, the Town Council found as a fact following public hearing on the matter that the petition for annexation is sufficient and meets all of the requirements set forth in N.C.G.S. 160A-31;

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF HOLLY SPRINGS, NORTH CAROLINA:**

**Section 1.** By virtue of the authority granted by N.C.G.S. 160A-31, the following described territory is hereby annexed and made part of the Town of Holly Springs effective as of the 7<sup>th</sup> day of August, 2018.

**Legal Description for Voluntary Annexation**

Beginning at a drill hole set on the Southern Right of Way of Bass Lake Road (SR 1393) (Variable Width Public Right of Way), said drill hole being South 70°59'35" East 6,604.84 feet (Ground Distance) from NCGS Monument "HOLLY SPRINGS" (NAD83/2001) having NC Grid Coordinates of N=692,052.27, E=2,049,733.25, thence from said Beginning point along said Right of Way South 78°50'41" East 99.66 feet to a drill hole set, thence South 78°50'41" East 100.09 feet to a mag nail set, thence leaving said Right of Way South 19°42'59" West 220.23

feet to a rebar set, thence North 78°33'32" West 100.02 feet to a rebar set, thence North 78°37'23" West 99.96 feet to a rebar set, thence North 19°48'35" East 219.39 feet to the Point and Place of Beginning containing 0.997 Acres more or less.

**Section 2.** Upon and after the effective date of annexation, the above described territory and its citizens and property, shall be subject to all debts, laws, ordinances and regulations in force within the Town of Holly Springs and shall be entitled to the same privileges and benefits as other parts of the Town of Holly Springs. The territory shall be subject to municipal taxes according to N.C.G.S. 160A-31.10.

**Section 3.** The Town Clerk of the Town of Holly Springs shall cause to be recorded in the office of the Register of Deeds of Wake County, and in the office of the Secretary of State, an accurate map of the annexed territory, described in Section 1, hereof, together with a duly certified copy of this ordinance.
